

How to find us:

The TLA has three locations in downtown Toronto:

361 University Avenue

- The Library and TLA offices - 3rd floor, Rotunda
- Robing rooms (lockers available for rent) - 2nd floor, Rotunda
- Lawyers' Lounge - 2nd floor, Rotunda
- Consulting/Interview rooms available for rent for TLA members only

330 University Avenue - *Please note that all facilities are currently closed for construction until Fall 2019*

- Lawyers' Lounge - 9th floor
- Robing rooms (lockers available for rent) - 9th floor
- Consulting/Interview rooms available for rent - 5th, 8th, and 9th floors, for TLA members only

393 University Avenue

- Lawyers' Lounge - 8th and 19th floors
- Robing rooms (lockers available for rent) - 8th and 19th floors
- Consulting/Interview rooms available for rent - 7th, 8th, 9th floors, for TLA members only

How to Find TLA and the Court House Library

The Courthouse at 361 University Avenue is a large building. For easiest access **TLA members can use their membership card** to enter the building at the ground level of the Rotunda entrance (south side of 361 University Ave.). Use the push bell to announce your presence and a Court Officer will buzz you in. You will have to show your TLA membership card to have the second doors opened. The lift will take you to the 2nd floor Lawyers' Lounge and Robing Rooms or the 3rd floor Court House Library.

If you do not have a TLA Membership card use the following directions to find the Library:

- Enter at 361 University Ave., which is north of Queen St., south of Armoury Street on the east side of University Avenue. You will pass through airport like security.
- Follow the hall to the escalators on your left. Take escalator to the 3rd floor.
- Go left and keep going left. You will pass through 3 sets of doors. The last set has a sign on it saying "Library", but you will not be in the library yet.
- To your right is a round tile-covered structure (elevator) and just past it is the library.



If you do not have a TLA Membership card use the following directions to find the 2nd floor facilities:

- Enter at 361 University Ave., which is north of Queen St., south of Armoury St. on the east side of University Ave. You will pass through airport like security.
- Follow the hall to the escalators on your left. Take escalator to the 2nd floor.
- You will go in the direction of Courtrooms 201-209, which is on the left, “behind” where you get off the escalator. Go left and keep going left.
- You will pass through 3 sets of doors. Eventually you will see signs indicating TLA Lawyers Lounge or Barristers Robing Rooms – you are going in the right direction.
- After the 3rd door on your right you will see a round, mosaic tiled structure. Pass it and through the doors.
- On your left you will find the Lawyers’ Lounge and on the right are male robing rooms. The female robing room is before the elevator.
- The TLA Boardroom is down the hall on the right side, room S206.

If you need parking there are several options:

- 89 Chestnut Street Residence is on Chestnut St, which is 2 blocks east of University Ave., accessible via Armoury St. (which runs parallel to Dundas St., 1 block south of Dundas St.) or Dundas St.
- City Hall underground parking which is accessible from Armoury St. and Chestnut St. or Queen St. and Bay St.

Subway

Osgoode subway station is a short block away. If you are unfamiliar with Toronto, you may wish to check the Toronto subway system (TTC).
