RE: ONTARIO LINE CONSTRUCTION – OSGOODE HALL

We are a group of legal associations whose members practice law in all disciplines throughout the province of Ontario.

We recognize the importance of accessible public transit in our community. Therefore, we commend all efforts to improve public transportation. However, planning for public transit should incorporate other community interests, such as preserving history and maintaining open natural spaces.

Osgoode Hall and the property surrounding it is a national heritage site. Osgoode Hall's building and graceful lands offer a tranquil spot in an otherwise busy urban space. Built in 1832, the building, wrought iron fence and grounds speak to history. John Howard, who designed High Park and St. James cemetery, was the first to design Osgoode Hall's lawns after the Law Society hired him to assess the damage caused when troops were stationed at Osgoode Hall during the Rebellion of 1837. Since then, the lawns and the gardens have been meticulously maintained.

The community's continued use of the space underscores its value. In the summertime, families take their wedding photographs, and many enjoy lunch on the lawns, ensuring that the building and its property are woven into the personal history of many Ontarians.

The Women's Law Association of Ontario (WLAO) is one of the signatories to this letter. In October 2022, the Law Society of Ontario placed a plaque on the grounds of Osgoode Hall

commemorating the WLAO's 100th anniversary as an organization. This special event is a reminder of the vital need to preserve our legal history for future generations.

We strongly urge Metrolinx to change its current plan to locate the new Osgoode Station on the Osgoode Hall grounds. Instead, the station should be located on one of the other viable options already presented such as the use of the property located on the northwest corner of Queen Street and University Avenue. It is our understanding that the property's owner has expressed interest in having the subway station located on those lands. Furthermore, we understand that there are no technical impediments to placing the subway station at that location. Alternative locations, such as the one on the northwest corner of Queen Street and University Avenue would enable the necessary expansion of public transit while preserving the historic Osgoode Hall grounds.

We have reviewed the Federation of Ontario Law Association's ("FOLA") letter dated June 1, 2022, and the Toronto Lawyers Association's ("TLA") letter dated June 13, 2022, written to you on this issue, and we agree with the comments referenced therein.

We would be pleased to discuss these matters further with you and look forward to further discussions on this issue.
