October 21, 2020 Summary

## Invited participants: Sector calls

## **Issues discussed:**

#### 1. COURTS

- On Friday, the SCJ issued a <u>Notice to the Profession and Public Regarding In-Person Operations in Newmarket</u> and a <u>Notice to the Profession and Public Regarding In-Person Operations in Toronto, Brampton and Ottawa</u>. Both are hyperlinked.
- ❖ Both the SCJ and the OCJ wanted to remind lawyers making any submission online to ensure that a contact email and phone number (with extension) is included with their filing.
- ❖ The OCJ has temporarily closed their Guelph Criminal Courthouse operations due to an HVAC issue. Operations have temporarily been relocated to Kitchener.
- Courts and MAG are working to locate alternate locations for the Thunder Bay Courthouse as a result of the fire. One possible location is the Provincial Offenses Act (POA) Courthouse. - ❖ MAG continues to explore the creation of a centralized online hub for those looking for protocols and processes when planning a visit to a specific courthouse or needing to conduct matters with a specific Courthouse.
- \* MAG is also still exploring ways to disseminate Dockets in a more efficient, consistent, and timely matter and are currently meeting with staff about this.
